On January 31, 1990, at approximately 0830, I was contacted by Sgt. Grider and requested to respond to 6th and Euclid. I arrived a few minutes later, I was then assigned to conduct surveillance at 2422 East 36th, which is a rental property owned by the victim.

I started my surveillance at approximately 0850 hours. I was then instructed to make contact with the tenant at 2422 East 36th. I attempted to contact NELLIE MAE DUNAM, who lives at that residence however, I could get no response from the door. As the building is a duplex I then went to 2424 East 36th and made contact with a Dervis and SAETA ALIJAJIC. They confirmed that the victim was the landlord, they stated they did not have much contact with him. They usually sent their checks in by mail and that they had been living at the apartment for approximately five years. They also advised me that they had immigrated from Yugoslavia approximately twelve years ago and had moved to Tucson approximately five years ago. They stated that the woman in the other part of the duplex worked at UMC and she was probably not at home. The phone number for 622-5963.

At approximately 0930 I was advised to secure from the surveillance which I did. At 1145 hours, I was contacted again by Sgt. Grider and advised to assist Det. Allen with surveillance at 2020 South Columbus. I arrived there shortly thereafter. The purpose of this surveillance was to locate a LINDA ABIB, who lived at that apartment complex. Shortly after the surveillance began, Det. Wright, from Homicide arrived. It was decided that due to the previous information we had that we should make a welfare check at the apartment. Det. Allen and Wright got the apartment manager to let us in and we took approximately one minute to check the apartment as it was a small apartment. While I was looking under the bed I noticed a computer sitting under there however, I did not touch it. I later made mention of the fact to Det. Wright that we had been looking for a computer

and that might possibly be one. During the welfare check all we did was check the closet, bathroom, bedroom and the kitchen/living room area. We did not open any drawers or conduct any kind of search. The door was then resecured and I continued surveillance with Det. Allen until she was called away for another assignment. I maintained surveillance until approximately 1620, until I noticed a Black, female returning to the apartments and entering apartment (459). I advised Det. Wright and Allen that the subject was now home. Det. Wright arrived approximately fifteen minutes later where she conducted an interview with LINDA ABIB in regards to the incident at the Mosque.

I also heard LINDA ABIB give her permission for us to take the computer. She was asked by Det. Wright to sign a Consent to Search Form, which she did, she was also given a Property receipt for the computer. I carried the computer which was an IBM and contained a hard disc drive, down to Det. Wright's vehicle where I sat it in the back seat. I attempted to keep the computer as level as possible so as not to harm the hard disc drive. I secured from the apartment complex at approximately 1815 hours.
