Dear Sir,

I'm writing to you regarding a patient, Steven King aka Mujahid Talib A. Mu'min, who was declared "brain dead" and was refered to Quranic Psychiatry Department, and was treated by three therapist who were able to give him treatment under my direction and was able to revive him under the very first instruction. The following day he opened his eyes, and when-ever not under heavy sedation he tried to communicate.

In this regard, I would like to thank you very much personally, and on the half of my staff who also treated him. I also thank you for your wonderful remarks and your willingness to make this methodology available in the case of critically ill, as patient mentioned above.

On page 36, "A REPORT" refer to case # 2, written in Dr. Gaber's own hand writing, you will see that the patient who was sent by the present King Fard, flown in by special plane, who was revived and was restored without given one pill or tranquilizer. This case was recorded and followed by a Christian doctor; Dr. Gaber.


I had also given lectures on this subject in England, at the Psychiatric Research Institute, Maudsley Hospital London, on the invitation of Dr. Julian Leff. You will notice that in Taif my research was a Christian, while in London Dr. J. Leff was a Jew. No where have I tried to restrict this Methodology to any ethnic or racial group. The knowledge related to this methodology is common heritage of all those who believe in the Almighty and His Message sent to Abraham, Moses, Solomon, Jesus, and the Last message given to Muhammad (peace be on them all).

There is a definite scientific basis, based on the esoteric laws upon which this methodology is based. It works on the clinic and the hospital level, and we are maintaining 5 centers in the U.S.

I'm very much sure that patients selected personally by me or by my staff in the U.S.A., out of that a good number would be healed, God Willing. I have already accepted to give a try to children born with "AIDS" in Calif. and this project will take at least 6 months to a year to show results, and will be kept strictly confidential. Your brain dead patient was healed because I knew the cause, and with God's help I was able to revive him. The same as with AIDS, and I know the cause. In a good number of these young patients who was born with AIDS can be healed. Regarding my conditions for treating patients, I only expect all the people of the Book to follow the Ten Commandments and lead a clean and healthy life.

I once again thank you for your kind words in which you expressed to my therapist and to Dr. Khadijah Baqi at Calif. There is a possibility I might come to the U.S. in the near future, and I will be looking forward to see you, with the hope to plan a joint project to help suffering mankind.
