INVESTIGATIVE FOLLOW-UP REPORT

NARRATIVE

On March 5, 1991, the RI, working in an undercover capacity, posing as a construction worker, was invited onto the property located at 31755 Highway 285/24, Chaffee County, Colorado, to make repairs on a mobile home on this property.

The RI made contact with a B/F, later identified as Estrelita Blout, at the upper house at approximately 12:00 noon. The RI requested a portable generator from Blout, so the work on the trailer could be completed. Blout pointed at a Honda Generator saying the RI could use this one. The RI moved the generator to the work sight.

In checking this generator, the RI observed a sticker on top of the generator from Center Rental which had been partly scratched off, although it could still be read. The generator also had what appeared to be an inventory number scratched on the frame. This number was 2935, along with the block serial number on the motor of GE400-1059665.

While working in the trailer house, this RI also observed an airchipper hammer along with a 12 inch point chisel in the hammer. There is an air hose attached to the hammer. I was unable to locate a brand name on the hammer although the serial number is 706049.

Also, the RI observed a blue Emglo Air Compressor, Serial Number A-030890011, Model Number K5HGA-8T. The RI also observed what appeared to be an inventory number 5490 scratched on the frame.

During the time the RI was on the property, the RI observed two McCulloch chain saws along with various other air tools in a tool shed located by the lower house. The RI was unable to obtain information on these items due to the fact that Blout was watching me. This shed door was open at the time the RI observed those items.

The RI observed nine (9) structures, including the mobile house, on

the property. These structures are located on the main road. They are located as follows: The gate to the property line is approximately 500 yards east of Highway 285/24. At that gate there is a brown Dodge wrecker, temporary permit 07328T, expiration date 09-06-88, and a white van, no license. Approximately 100 yards north of the mobile home is a wooden building with the door on the west side. This building has no windows. There was a Pontiac 4-door, silver in color, Vin. # 1G2AY37588612, License Plate PRF, Colorado.

Approximately 400 yards east of the mobile home is a house on the south side of the road. There are windows on all sides, with the door on the south side of the house, away from the road. The windows on this house are covered with newspaper and the RI was unable to see inside. Across the road to the north is a tool shed with the door facing the road. There also is a blue van parked at this house, no license plates.

The road splits to a Y at this point. To the north is a wooden structure, possibly a guard tower. This is 400 to 500 yards from the house.

Some 300 to 400 yards to the northeast of the above house is a second house. Windows on all sides and the door faces south. There is only one door on the house. This house is where subject Blout was contacted. There were a number of children in this house. There is a shed, containing a number of small pups. To the east of this house there is another shed with a door facing the house. It is unknown what is in the structure. There was a white/blue Jeep wagon parked in front of this structure. The RI could not see if there were any windows on the side of the building.

Attached to this report is a drawing of the location of buildings and vehicles.

The RI returned to the District Attorney's Office in Salida, Colorado, where this RI met with Investigator Wallingford and Undersheriff David Bowers. The RI was shown a number of color photos and was able to identify the above listed subject, Estrelita Blout as the party I spoke with.

This RI also was able to review reports received by Investigator Wallingford and Undersheriff Bowers received from Woodland Park Police Department, WPPD CR 91-070, dated 1-19-91, reporting an Emglo air compressor, Serial Number A030890011, and a Honda Gas Generator, Serial Number 1059630, as stolen from Center Rental, 2401 Steel Drive, Colorado Springs, Colorado. These items were reported stolen by a Darryl Woods, 7410 Colonial Lane, Fountain, Colorado.

Also this RI reviewed a Manitou Springs Police Report dated 1-19-91, MSPD CR 91-0050, listing a Harper air chipping hammer, Serial Number P06049, reported stolen from Wagner Rents, 3026 Delta

Drive, Colorado Springs, Colorado. This item was reported stolen by a Kenneth Green, 4747 N. Hackamore Drive, Colorado Springs, Colorado.

This investigator has no other information in this matter at this time.
