Supplement Notes

On November 29, 2012 Det. Foust asked me to place an Arizona Drivers license for "Benjamin Edward Phillips" from the case file into evidence. She specified that the license would be attached to a lined note pad paper with hand written notes on it. I took it from the case file and submitted it into evidence (item #1MC).

On November 30, 2012 DCA C. McGinley requested that I bring the following items of evidence to court on Tuesday December 11, 2012. I submitted a request for the following items:

1TM-note found by Det. Miller at 274 N. Hopi
3TM- envelopes of mail from case file marked Ben Phillips mail
100TM- glasses, wallet, credit cards
102TM-tan leather jacket only
1KSW-A- envelope containing head hair from Benjamin Wall
1GO-print lift card by CSS Ortiz
1MC - AZ driver's license for Benjamin Edward Phillips

On December 10, 2012 I called the evidence section to confirm that the items would be ready for pick up tomorrow. Evidence technician B. Hansen told me that item 1KSW-A was checked out to Lab Corps, and that item 1GO was housed with the latent print examiner (P. Gasparro). I conferred with DCA C. McGinley and he explained that he no longer needed item 1KSW-A for trial, and that LPE P. Gasparro could bring the print evidence when she testifies.

Evidence Technician B. Hansen also informed me that item 102TM was packaged together with 103,104, 105, and 106TM. I will separate the jacket out for trial when I check out the evidence for transport to court tomorrow.

On December 11, 2012 I separated the jacket from the rest of the items packaged with it. It's new item number is 102-106TM.01. The jacket was individually sealed so I didn't have to disturb it or the other items in the same back. I then transported items 100TM, 102-106TM.01, 1MC, 1TM, 3TM to Superior Court Judge Browning's court room and turned them over to the court clerk, Sabrina West.

On December 19, 2012 a jury found Glen Francis guilty of first-degree murder. DCA C. McGinley asked me to make arrangements to collect the
