On January 23, 1990, I responded with Det. Kouratou to the Mosque at 739 E. 6th to interview a Dr. Khalifa. Det. Kouratou and I first came in contact with the subject I later became known to be as Edip. He let us into the Mosque and then went to a door at the far side of the room in an attempt to contact Dr. Khalifa. He had to go to the door three separate times before Dr. Khalifa came out. Det. Kouratou questioned Dr. Khalifa about any threats against him and the Mosque. He indicated to him that some pictures of the Mosque had been found in Colorado. Dr. Khalifa indicated that he received a threatening phone call from someone in Colorado approximately 2 months prior and that he had made a police report. Det. Kouratou also asked him if he knew a group called Fuqra. Dr. Khalifa stated that he had never heard of that. Dr. Khalifa stated that he was receiving threats all the times because of his religious beliefs and that most Moslems were against him because of these beliefs. I asked Dr. Khalifa if his sect went by any name, however he indicated that it did not.

During the time that we were talking to Dr. Khalifa a subject known as Edip was standing right to Dr. Khalifa's right and was nodding in agreement with the statements that Dr. Khalifa made. We advised Dr. Khalifa that we had no information of any specific threat against him at that time, that we were just attempting to pay (ph) any information that we could. Det. Kouratou gave Dr. Khalifa a business card with his name and also Sharon Allan's name.

We also did not mention a time frame as to when these pictures were found. We then left the Mosque and I had no further conversation with Dr. Khalifa nor did I return to the Mosque until the day of the homicide.
