At 0542 hrs., Reserve Officer Kurz, #22746 and I were dispatched to 741 E. 6th St., to contact the complainant on a shooting call that the complainant told the Police Service operator had occurred at 739 E. 6th St.

We arrived on the scene at approximately 0545 hrs and were contacted by LPO Lorenson, who instructed me to interview a female wearing a red dress and a gray sweater. She was barefoot and was semi-hysterical. I immediately isolated her from other people who were there and asked her for her name and address. She stated that her name was Lisa Bess Spray, DOB determined address of 741 E. 6th St. She is employed by the University of Arizona by the Physical Resources Dept., and works 0700 hrs to 1600 hrs., Monday through Friday.

0700 hrs to 1600 hrs., Monday through Friday. Ms. Spray told me that she is an assistant to the victim and that she has a key to the kitchen door to the temple at 739 E. 6th St.

I then asked Ms. Spray what had occurred that had caused her to call 911 and she gave me the following information:

She went to the kitchen door to the Mosque to pray and found the door to be locked, which is unusual. I asked her what time this was and she replied about 0625 hrs.(I observed that the present time was 0555 hrs.) I asked her what happened when she found the door locked and she replied that she had opened the kitchen door with her key and observed that the lights were off and the kitchen was dark which is unusual. She then turned on the lights and observed that the door between the kitchen and the Mosque was open which is very unusual. That door is usually locked with a sliding bolt. She stated that she then looked down and observed the victim lying on the floor near the refil gerator and that he did not appear to be breathing. She states that sne smelled the strong odor of gas in the room, but it didn't smell like natural gas, but more like kerosene. She then observed that all of the burners on the gas stove were turned on but not burning. She stated that she immediately turned off all of the burners and opened the kitchen door to let the fumes out, and then ran to 742 E.6th St and asked the victim's

brother in law to call 911. She stated that Ahmad answered the door and called 911.

I asked Ms. Spray what she did after asking Ahmad to call 911, and she replied that she returned to the front of the Mosque to stop any arriving worshipers from entering the Mosque and seeing the victim. She states that she remained outside of the front of the Mosque until the first Police unit arrived then went to the front of 742 and remained there until I contacted her.

I asked Ms Spray to wait in a bedroom at #742 and kept her isolated until Victim Witness counseller, Vaughh Pyle arrived at the scene and was able to talk with her. No one except myself and Mr. Pyle had contact with Ms. Spray from the time of my arrival at the scene.

I remained with Ms. Spray at #742 until Detective Jimenez arrived and instructed me to transport her to 270 S. Stone and keep her isolated in an interview room. I transported her to 270 S. Stone and remained with her until relieved by Detective Karen Wright at approximately 0900 hrs.

I have no further information reference this case.
