**OFFICER'S STATEMENT:** While conducting the Search Warrant on 08/13/01, INS Special Agent Berton and I (Detective R.G. Newbury Jr., 1338D) observed two (2) vials of the liquid drug Testosterone on the suspects' bedroom dresser drawers.

On 08/15/01, I contacted Olympic Training Center (OTC) Manager of Security (Charles George) regarding the discovery of the vials of Testosterone. I asked Mr. George to check with their medical staff to determine if this drug was legally prescribed to or through them to Suspect Aziz. He called back later and advised that the medical staff advised that the drug Testosterone is a "banned" drug for the OTC athletes and that the use and possession by Suspect Aziz (as a member of the OTC Judo Team) was forbidden.

On 08/16/01, Special Agent Berton advised me that he spoke with DEA Special Agent (Diversion Investigator) David Brown regarding the Testosterone vials. Agent Brown advised Agent Berton that the Testosterone substance is categorized in the Federal Controlled Substance Schedule III table/guidelines. Agent Berton stated that DEA advised that the substance(s) should be confiscated.

On 08/16/01, Special Agent Berton and I responded to the chambers of the Honorable Judge S. Sletta with an Application and Affidavit for a Search Warrant of the residence at [REDACTED] to secure the two (2) vials of the liquid drug(s). Judge Sletta signed/issued the Search Warrant without change(s).

On 08/16/01, at approximately 4:30 p.m., INS Special Agent Berton, DEA Investigator Brown, DEA Special Agent Sanders, and I responded to [REDACTED] to execute the Search Warrant. We initially found no one home at the residence, however the front door was unlocked. Officers entered, secured the residence, and began the search. While searching, RP/Misty Meredith and her boyfriend arrived at the home.

I confiscated vials of the following drugs while in the suspects' bedroom (on top of the dresser drawers):

1. Testosterona 200, lot #12, Expires 07/01/03, made in Mexico, Broyel Laboratories.
2. Norandren 200, lot # (unreadable), Expires 05/2002, made in Mexico, Broyel Laboratories

Investigator Brown confirmed that the Testosterone is a Schedule III Controlled Substance. He stated that the Norandren is a steroid drug.

The aforementioned two vials of clear liquid were placed into evidence in support of this case report investigation.

According to the Physicians Desk Reference (PDR):

1. Testosterone: Schedule III Controlled Substance; available by prescription only.  
Used to promote growth and development of male sexual organs and secondary sexual characteristics.
2. Norandren: Nothing listed.
