PRESENTLY WE ARE ALL AWARE OF THE INCARCERATION OF FIVE OF OUR MUSLIM BROTHERS WHO WERE ARRESTED IN CANADA.

NO? YOU ARE NOT AWARE OF THIS?

OR IF YOU ARE AWARE DID YOU INQUIRE AS TO THE STATUS OF THEIR SITUATION? DID <sup>you</sup> INQUIRE INTO THE CATEGORY THEIR FAMILY MAY HAVE BEEN PRESSURED INTO?

WELL ASK YOURSELVES MY BROTHERS, HOW WOULD IT BE IF THE MAN OF YOUR HOUSEHOLD (MEANING YOU) WAS LOCKED UP. WHO WOULD SUSTAIN YOUR FAMILY WITH THE DAILY NECESSITIES, PAY THEIR RENT, SEE TO IT THAT THEY ARE NOT EVICTED OR FORCED TO LIVE WITH NONMUSLIM RELATIVES? WHO CAN YOUR FAMILY TURN TO, FOR ENCOURAGEMENT THAT "ALLAH IS THE GREATEST"? KNOWING THAT THE SPIRITUAL HEAD OF THE FAMILY ENTITY IS NOW SEPARATED FROM THE BODY, ALLOWING SHAITAN TO WHISPER INTO THE HEART OF YOUR WOMAN, SAYING "YOUR HUSBAND'S COMPANIONS ARE NO GOOD -WERE ARE THEY NOW? IT SEEMS AS IF HIS FAMILY WAS NOT AN EXTENSION OF YOURS, NOR IS HE HIS COMPANIONS KEEPER".

IF YOU CAN RELATE TO THE ABOVE READ ON!

THE PLIGHT OF THE BROTHERS INCARCERATED IN CANADA IS NOT ISOLATED, IS NOT ISOLATED TO JUST AFFECTING THEM. THEIR FAMILIES ARE LOOKING TO THE JAMAAT (BROTHERHOOD AS A WHOLE) FOR SOME TYPE OF ACTION. BE IT MONETARY OR OTHERWISE. OUR BROTHERS ASKED ME WHEN I WENT TO SEE THEM IN THE CANADIAN JAILHOUSE, COULD I PUT SOME MONEY IN THEIR ACCOUNTS SO THEY CAN PURCHASE SOME HYGIENE ITEMS IE; TOOTHPASTE, SOAP, ETC.

ONE OF THE BROTHERS WIVES ENQUIRED AS SHE WAS FORCED TO STAY WITH HER IN-LAWS DUE TO NO INCOME, HER HUSBAND WAS THE SOLE PROVIDER FOR HER AND THEIR DAUGHTER. SHE ASKED WAS IT O.K. IF SHE STAY AT A WOMANS SHELTER UNTIL THE HOLIDAY SEASON PASSED. THIS IS ONE OF OUR MOTHERS I'M TALKING ABOUT, DID YOU HEAR THIS? IS YOUR HEART NOT MOVED TO TAKE ACTION? THESE ARE JUST SMALL ISOLATED INCIDENTS OF A MUCH BIGGER PICTURE.

DIDN'T YOU KNOW THAT THE BROTHERS WERE ARRESTED?  
DID YOU OFFER ANY MONEY FOR LEGAL FEES, THEIR FAMILY OR OTHERWISE?  
DID YOU INQUIRE TO SEE IF ANY WAS NEEDED?

WELL THE BOTTOMLINE IS, THE BROTHER'S NEED MONEY TO PAY THEIR ATTORNEYS, THE FAMILIES ARE ALSO IN NEED BUT TO THE SUPPORT OF THEIR MEN THEY ARE WILLING TO SURVIVE ON LITTLE. ALSO THE BROTHERS WHO HAVE BEEN GOING TO VISIT, AND CONDUCT BUSINESS FOR AND ON BEHALF OF OUR BROTHERS HAVE RECEIVED ONLY \$40.00 FROM THE JAMAAT AS A WHOLE FOR GAS FOR 4 TRIPS TO CANADA AND TWICE THEY'VE HAD TO PROCURE A HOTEL TO STAY OVER IN ORDER TO DO A THOROUGH JOB LEAVING NO STONE UNTURNED, IN CONDUCTING BUSINESS AS A JAMAAT/BROTHERHOOD OR OTHERWISE. WE'VE HAD TO SECURE FIVE DIFFERENT ATTORNEYS ONE FOR EACH BROTHER AT TWO THOUSAND DOLLARS(2000.00) EACH AS A RETAINER.

ON BEHALF OF THE BROTHERS INCARCERATED I BESEECH THE HELP OF MY OTHER BROTHERS AND SISTERS FOR THE CALL TO GO OUT FROM THE MOUNTAINS UP HIGH AND ABROAD "GIVE IN THE CAUSE OF ISLAM FOR THIS CAUSE.

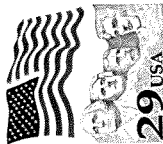
