Q	Is that right? Could you tell me from when you first, how you became in contact with him to begin with?
A	Well, I rented an ad through the Tucson Shopper and he took my name and number out of the Shopper. And after a few jobs Iafter the first job everytime he needed something done he'd call me.
Q A	And this was about how long ago? About 14, 15 months ago.
Q	What was yourwhatdoes he own other property that you did work on also?
A	Yes, hehis son owns thetwo duplexes on 18th and Tucson. And he has two apartments on 36th Street. He has a house on 34th. And then he has the six apartments and the mosque on 6th and Euclid. Then he has his residence on East 2nd Place. Then he has these three here on 17001727, 29 and 31 East 13th Street.
Q A	And you've done work on all or you Yes.
Q	done some repair. Drawing your attention to particularly the mosque, while yourwhile you were working around that area, when is the last time that you did work on the mosque, do you recall?

- A The last time I worked on the mosque was about last week. I replaced the doors on the rear entry, the one there wasn't very sturdy so I replaced the door, I reinforced the lock.
- Q OK, prior to that, particularly prior to the date of the murder of..
- A I worked for him the night before.
- Q OK, what did you do then? A Well the day before I was here painting the apartment. I..the next evening I stopped by to tell him that the people were moving out of here, 1729 so it was about.
- Q That was Tuesday?
 A The night before the murder, yes, it was about six o'clock. (inaud) when I talked to him.
- Q And you talked to him at the mosque?A At the mosque, yes.
- Q In his office or where?
 A No, just on the rear steps by the back entry there to enter the kitchen area.
- Q Do you recall the conversation as it pertained to.. just the repair work or was there any other.. A No, it was just..basically that night it was just that I went back to tell him that these people were moving out. I didn't think that he realized that they were moving out. Because..and I think they were paying on this for about three or four days and at the time that..prior to that they had, you know they weren't moving out, it was just the last day or so they started moving out so I didn't think he was aware thta they were moving out so I stopped by to tell him.
- Q OK, were you there long or approximately how long were you there?
 A I was there probably half hour, 20 to 25 minutes.
- Q Did you notice anybody else in the..
 A No, just the normal people in and out you know.
- Q The people who were.. A Yeah.
- Q ...doing the service on..
 A Yeah, the people that are usually there at the mosque.
 And he was having prayer meetings at 4:30 you know,
 5:30, 6:00 so it was just the normal people that were there.

Q OK, are you a member of the congregation over there? A No.

Q Did you notice anything unusual? A Just the last few days I noticed that he was..he was (issued) it shapeed it you know it seemed to me like

(inaud) it changed..it you know it seemed to me like he was worried about something, you know. (phone rings) Let me get this.

- Q OK, I'll stop the interview, the time is approximately 0910....OK, we'll continue the interview, the time is still 0910. Could you pick up from, from what you were talking about, him being depressed. Yeah, he..he didn't seem to be depressed, he just.. Α everything was kind of different with him. You know I tried to talk him into clearing the brush from around the mosque and he said it was, you know, the little things now, he said, that at the time didn't mean anything but he said well, it would keep intruders out. And I tried talking him into cleaning it up so, you know, that if they did try to break in they could possibly see it but..he just didn't seem to, you know.. he just seemed to think that somebody was gonna break in or something. And then I noticed that..before there weren't any signs on the windows, he started putting signs on the back door that you know, that was a private area, he didn't want anyone coming through the..you know, to go to the front door of the mosque. And I noticed there was locks being put on a lot of the doors.
 - On the interior doors or the.. On the interior door, the one between the kitchen and the mosque itself, there was you know an additional couple of locks on that which before they weren't there.
 - Do you know what condition those locks were in? They..they weren't very sturdy. They..I mean they wouldn't have held out anyone. They were more or less just to deter someone from trying to open the door and go through and then you know, it wouldn't go any (inaud) put your shoulder against it, it would pop right out.
- Q Let me ask you: did you ever go over there..did you usually enter through the eastside door there? A Yes.

Q The back door? A Yeah. Usually everyone did except the members of the mosque when they were going in to the prayer meetings or something. PAGE 4 SONNY ROBERTS

Q And the times that you went over there, were you generally expected or did you ever go unexpected? A I..I would go unexpected, yeah, at times you know, I would go ask him something or tell him about some piece of property that I'd stopped by and checked on.

Q Would he verify that it was you before he opened the door?

A Oh yes, there was a, there was a window there, he'd just look right out and see who it was.

Q Did he generally do that? A Yes.

Q Do you know anything about the trailer that's in back of the..

A Just that it belonged to a, a lady that used to be his secretary, work with him or something at one time a few years back.

Q Did you ever know anybody by the name of WALTER? A Yes.

Q Could you tell me a little bit about WALIER? A Matter of fact he worked for me on a job one time. He.. he didn't seem to be, you know, the normal type Muslim. And when he was working with me he was talking about drugs and you know, drinking and wanted to get off and have a few beers. He just didn't seem th enormal type Muslim, you know. Other than that I couldn't tell you too much about him.

Q About how long ago was it that he worked for you?
A Oh it was..at least four or five months ago. It was last summer..

Q Did he work a great deal or..
A No, just..just one day, two days actually. He helped me install a cooler.

Q Do you recall his last name?
 A No, I don't. I just knew him as WALTER.

Q Did you pay him in cash or did you write him a check? A I paid him in cash.

Q OK. Could you describe him to me as best you could?
 A Well, he's a black man about 5..5-7, 5-8, probably 185 pounds. No noticeable scars or anything.

Q Any facial hair, mustache, beard? A Well he had a mustache, he had kind of a beard but just a short-cropped beard. Or maybe just you know, hadn't shaved in a few days. PAGE 5 SONNY ROBERTS

Q Did he, when he worked for you, how did he come to work for you?

- A Well, RASHAD told me that he came from back east someplace and he didn't have a place to stay and he was staying in a trailer and RASHAD said that he was, you know, an electrician and he was needing some work. Occasionally when I need you know, someone or something, RASHAD recommends somebody that you know, they were in need of money and some work so if I could I'd work them a day or so so they'd have a little spending cash.
- Q Did he seem to be knowledgeable in electronics? A Yeah, he was very knowledge on electrical. As a matter of fact he worked for an electronics place.. it's over by the University. With some guy who was reparing stereos and VCR's and stuff like that. But he was working on a commission basis and he just couldn't make any money.
- Q You don't recall the name of the place, do you?
 A No, I don't.
- Q Is this what..this is just what he told you?
 A Yes, just you know in conversation with him during the day.
- Q And what type of work did he do for you, wiring or something?
 A Yeah, he wired up an electric swamp cooler for me, (inaud)
- Q And this was again, just one day did you say?
 A Yeah, just one day.
- Q And he was..RASHAD had referred him to you because he was in need of..
 A Yes.
- Q ..some work and he was a member.. A Yes, right.
- Q ..at the mosque there. And..anything else you can recall about his description? A No.
- Q Did he have any type of an accent that you recall? A No, it's more like a southern..southern-eastern accent you know, kind of a combination of the south and New York together.

Q Did he..did you get a feeling or do you have any idea where he came from or if he's still in town or .. I don't know if he's still in town. I...I just kind of Α got the idea that he was a drifter from, you know, from talking to him, just that he hadn't settled down in one spot for too long. Q What was his age, I forgot to ask you that? Α It was probably around 30, 32 I would say. Do you know how long he lived in the trailer back there? Q Well, to the best of my knowledge probably about three А weeks, maybe a month.



You know, at nighttime when I'd be over there they'd be cooking dinner and everything, they'd always you know invite me to eat with them and stuff like that.
